174 registrations. 73% increase from first year which had 116 registrations

153 showed (first year 85 showed)

Next year – Will work with athletics to avoid conflicts. If had conflicts, athletes could sign in/sign out.

Donations and Parent Volunteers about the same as past years

Family from Kid Again there and impacted the kids. They nagged less and actually got the need to stand and were thankful.

Success of event depends on kids.

\$815 parent raffle donations – down from last year because donations requested electronically

In-kind donations - \$640 (gift cards, water bottles)

Other food donations - Cowboy donated dinner of pasta and meatballs that the kids loved. Pizza and pulled pork donated, raised and glazed Donuts

Different Committees for food, public relations, fundraising, etc. kids set these up

Allison and Lynne put in over 200 hours on this. Kids all put in 50 plus hours each. Met with Lynne and Allison for 1 hour meetings starting in summer

PTO Council has 10 day fundraising rule but needs to be better way to raise money so kids are not confined to 10 days if can't get to businesses in that time frame.

80% of parents just write \$50 check

Fundraising debate occurred. Asking too much of parents and businesses. Same businesses getting hit up.

The Bash builds great spirit within the school, getting students involved. Need a fundraiser to cover the budget.

Raised \$16,402 (last year \$19,129)

Expenses were \$5,987

Profit \$10,415 (last year \$12,500)

Member requested a formula to determine how much goes to PTO, each class, and charity.

Large discussion took place discussing the distribution of funds, future of event, pros and cons of the event and its effectiveness for the kids involved v. the all of the students. How can the event be changed to attract more kids and more volunteers. Should this become a Club rather than a PTO fundraiser given PTO fundraising restrictions.

Since there was not a quorum present to vote, discussion was set to continue to next meeting.
